Whereas the Talent is a professional speaker/actor/presenter:

Article 1

The Talent will be at the disposal of the Producer **on Saturday 24th of February 2018 or Sunday 25th of February** (cross out which does not fit).

Article 2

The Talent hereby grants following final and irrevocable rights to the Producer:

1. To work with the Talent as thought required by the Producer for the period as defined in Article 1 of present agreement, more specifically to rehearse and perform in preparation and during the Production.
2. To capture the Talent by any possible audio-visual media and use the Talents image while displaying the final edit, or portions thereof, for a UNLIMITED TIME starting from release of the approved result(s) to the Client, conform the following usage scope:
 - WORLDWIDE FOR ONLINE USE ON CLIENT WEBSITES / SOCIAL MEDIA CHANNELS
 - WORLDWIDE BELOW-THE-LINE, INTERNAL, BUSINESS TO BUSINESS
 - No Above-The-Line, radio/TV commercial, broadcast or re-sale.

Article 3

The Producer commits himself to take out an insurance policy that will cover eventual accidents with the talents on the set. On request the producer will provide a certificate of insurance to the Talent agency.

Article 4

The Talent guarantees that the permission and rights assigned to the Producer by present agreement solely are to be assigned by him and that he is free and entitled to conclude this agreement. Furthermore the Talent guarantees that he has following rights in hand: all rights with regard to the appearance of the Talent that enable him to grant right to the Producer to film the talent.
